 - + Users are needed to sit for long duration in library so an ideal library should provide drinking water facility and separate rest room facility for gents and ladies users. Librarian should consider the need of physically handicapped and differently abled students. They should be provided ramp for entry in the library. They

should be given separate reading room catering their special needs like Braille Facility, audio system, little ABRAR software etc.

- + The reference section of library should be designed in such a way that users can access them ready at hand specially entry in service books.
- + A library building should be fire resistant, it should have enough number of fire extinguishers. The building should be under CCTV surveillance to avoided theft and misbehavior. A safe property counter should be maintained at the entry of library where the students can deposit their belongings.

3.9 Reading Room

The reading room should be as per UGC norms and it should be located adjoining the main library and easily accessible to students and librarian should take care that it is should be properly illuminated and ventilated. Its furniture should be comfortable so that students will not feel inconvenient to sit for long hours. The space of the reading room should be adequate to accommodate the students.

Separate reading room facility should be made available to the students opting to appear for the competitive exams. We should provide special facility to differently abled students. The timing of reading room should be flexible enough to fulfill the demand of users. It can be extended during university and other civil service examinations. A list of websites of competitive examination should be highlighted in the front of reading room as most of the students of today's generation are interested in getting government jobs.

A number of magazines and periodicals are available in the reading room but the students do not have knowledge about their availability. A list of such periodicals should be highlighted in the reading room and should be placed in such a way that they are easily accessible the users.

If a library is not capable of procuring all kinds of books due to financial and space barrier the users can be provided inter library loan facility by previous agreements with some reputed and standard libraries.

If a library is capable, it can provide certain reference services like entry in service books to off campus users at some nominal fees that can be utilized for the improvement of library. Extra space should be provided in the reading room for other group activities, projects and reference service beside room for librarian, circulation counter, reference desk, books/periodical display, committee/conference room property counter, catalogue enclosure etc.

As the librarian goes under, orientation and refresher course for getting the advanced knowledge the technical and supporting staff of library should also be sent for training programmes so they can provide better service to users.

One student representative is made member of the library committee, he should be encouraged to involve actively for the improvement of reading room services.




Fig.Ranking of Status of availability of Library Furniture according to adequacy




Fig.: Ranking of status of availability of equipment in the Libraries according to adequacy.




Fig.: Ranking of status of Reading Room facilities according to their adequacy

CONCLUSIONS AND SUGGESTIONS

Following data collection, statistical analysis was carried out and the results were interpreted in view of the study objectives. The conclusions drawn on the basis of statistical analysis of data are presented hereunder:

CONCLUSIONS:

- 1.Most of the colleges (75%) colleges, the library is not housed in separate building or according t UGC norms with separate functional space.
- 2.A very large no. of Libraries (85%) Libraries have expressed need for separate reading room for those uses who prepare for competitive exams.
- 3. In many of these college libraries (40%) the availability of Study Tables and Chairs is inadequate
- 4.The facility of photocopying machine, Water Cooler is highly inadequate in most of these Libraries.
- 5. Just about 4% of these college libraries have air conditioning.
- 6. There is acute shortage of air conditioning facility in these libraries.
- 7. There is acute Shortage of Cubical for Readers in these Libraries.
- 8. The facility of Rest Rooms/Toilets is highly inadequate in most of the Libraries.
- 9. The facilities for physically challenged students are very poor in majority of these Libraries.
- 10. The facility of ladies toilets is inadequate in most of these libraries.
- 11. About one third of the Libraries have inadequate number of Library professional staff.
- 12. The availability of semi professional staff is also poor in these libraries.
- 13. In many college libraries, no training is conducted for the Library staff to improve their professional skills, so as to assist users with collection related with competitive exams.
- 14. In majority of these libraries, only 1-2 PCs are allocated to the users for services.
- 15. Hardly any (only 6%) of these libraries are using the ex-students feedback to make necessary provision in the budget for purchasing books and upgrading the facilities in the reading room.
- 16. Lack of orientation to library staff in giving services to users regarding competitive exams.
- 17. Lack of policy for building collection in these libraries.
- 18. Lack of proper budgetary provision related with library furniture for competitive exams.
- 19. Lack of will for enforcement of UGC norms for Library Building
- 20. Lack of will of authorities to adopt UCG norms regarding reading rom facility in Libraries

SUGGESTIONS

- 1. The researcher suggests that their should be a separate collection development policy for competitive exam related furniture and infrastructure in the college libraries reading room.
- 2.It is suggested that Arts college managements or the universities to which the colleges are affiliated should increase the budgetary allocation for developing all collection pertaining to the resources needed by the students for preparation of competitive examinations.
- 3.It is suggested that Arts college management should take initiatives for making College libraries fully furnished so that all the activities in the libraries go on smoothly.
- 4.The library staff as well as faculty members should collaborate to prepare a repository of the information related reading room to competitive exams.
- 5. It is suggested that independent building be made available for all libraries of Arts colleges in Vidarbha region.
- 6.Computerization of Arts College libraries should be given utmost importance, especially in view of the importance of the competitive examinations and its utility
- 7. Separate Reading Room Facility should be made available to the students opting to appear for the competitive exams
- 8. Appropriate Toilet facilities for the girl students should be developed in the College premises.
- 9.The infrastructure development should be carried out by keeping the needs of physically challenged students.
- 10. Colleges should provide the funds to the library for procurement of furniture so that maximum students should make use of them for academic purpose
- 11. It is suggested that every Arts College Library should install UPS to get rid of power fluctuation.
- 12. Necessary steps should also be taken to develop competent library human resources for proper staffing of automated library systems.
